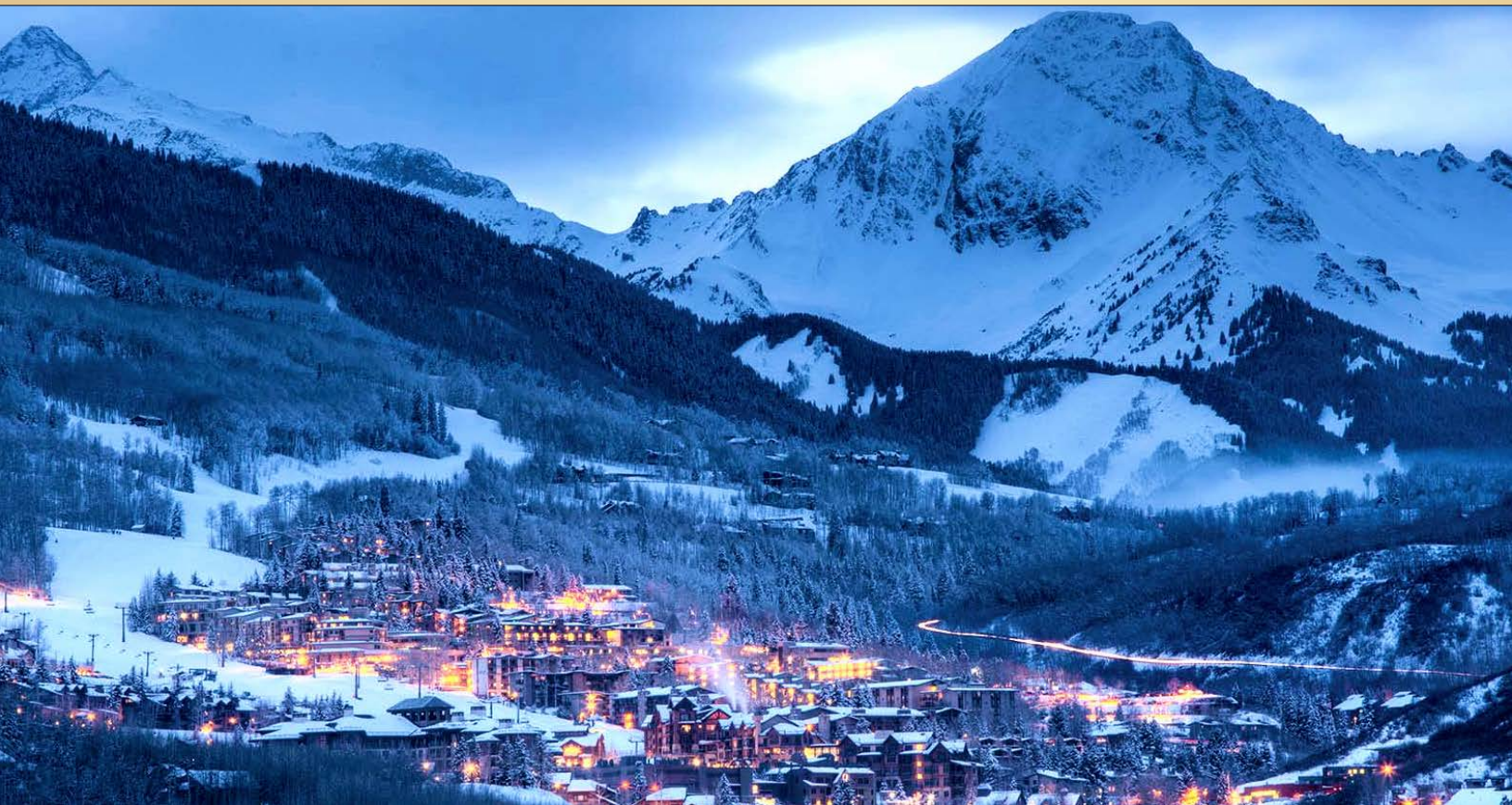

The LADC will explore the Viewline Resort Snowmass & Wildwood Complex, adjacent to the slopes of Snowmass Mountain and the Snowmass Village Mall. The Viewline Resort offers an ideal location, just steps from the slopes and the finest shops, dining and nightlife in Snowmass Village.

Snowmass Mountain is covered with perfect Colorado powder, and it is massive enough to offer up every type of terrain from serene to extreme. Twenty lifts deliver you to more than 3,300 acres, which include 98 trails totaling 150 miles and seven on-mountain restaurants.

NOTE Aspen Times: *The Westin and Wildwood Properties, as well as the Snowmass Conference Center, sold for nearly \$70 million in mid-December 2020. Two longtime Snowmass Mall properties will get a facelift in 2021; renovations will revamp the two properties under new ownership and management.*

PRICING & REGISTRATION

Cancellation: Registration Fees will be refunded only if a written cancellation notice is received by **January 31, 2022**. A \$75 Administrative Fee will be deducted from any refund. Any cancellation made after **January 31, 2022** is non-refundable.

RESERVATIONS: The LADC has reserved a small block of rooms at the Wildwood Hotel. The group rate for a king or double queen is \$189 per night. One bedroom suite is \$249 per night. Hotel's room rates are subject to applicable state and local taxes (Currently 12.8%).

Hotel Service Charge: The hotel charges a \$25 per-room fee plus tax, which includes Aspen-Pitkin County airport (ASE) pick-up and drop-off, ski or bike check, High Speed Internet Access, and local 800 telephone calls.

FLYING TO SNOWMASS: Aspen Snowmass Airport (ASE), United and American Airlines offer several options for nonstop flights each week, flying directly from 10 cities into Aspen / Snowmass Pitkin County Airport (ASE). Snowmass is a mere 6 miles from the Pitkin County Airport, which means you can get from gate to gondola or the town of Snowmass Village in 30 minutes.
